Re: Announcement of Planned Action

We are writing to inform you that there will be a location closing at the Applegreen facility located at 500 Vankirk Drive, Beckley, WV, 25801. The entire location will be closed and all employees at the location will be impacted. This plant closing is expected to be permanent.

On September 30, 2022, all affected employees were provided notice of the plant closing and their separation dates via USPS. A copy of the notice is attached as **Exhibit A**. Those employees are expected to be separated from employment beginning on January 31, 2023, with all separations accomplished by February 1, 2023.

Attached as **Exhibit B** is a list of the job positions/titles of the affected employees and the number of affected employees in each job position/title as well as the schedule for separations. There will not be any bumping rights for the affected employees, that is, employees will not be able to displace more junior employees out of their job positions as a result of this closure. There is no union representing affected employees.

As you may know, our service contract is ending in West Virginia for the Beckley Welcome Center, 500 Vankirk Drive, Beckley, WV 25801, at the end of January 2023. We were unable to extend the contract at this time. We expect the closure of the Beckley Welcome Center to be completed no later than January 31, 2022. The entire facility will be closed and all employees at this location will be impacted.

We regret to inform you that you will be terminated on **Tuesday, January 31, 2023**, unless you accept a transfer to a different location. Your Company-provided benefits will end on that date.

You are also hereby notified that, as a result of your employment loss, you may be eligible to receive job retraining, re-employment services, or other assistance with obtaining new employment from the West Virginia Department of Labor or its workforce partners upon your termination. You may also be eligible for unemployment insurance benefits after your last day of employment. Whenever possible, the West Virginia Department of Labor will contact your employer to arrange to provide additional information regarding these benefits and services to you through workshops, interviews, and other activities that will be scheduled prior to the time your employment ends. If your job has already ended, you can also access reemployment information and apply for unemployment insurance benefits on the Department's website or you may use the contact information provided on the website or visit one of the Department's local offices for further information and assistance.
