Re: Closure of Kroger Store #739 – Gassaway, WV

Dear Ms. Parsons:

This notice is being provided pursuant to the Worker Adjustment and Retraining Notification Act of 1988 (“WARN”), which requires employers to give official notice to certain government units or officials of certain plant closures or employee layoffs.

Please be advised that between January 1, 2023 and January 31, 2023, Kroger Limited Partnership I will close its Kroger grocery and retail store location within Braxton County at 2908 State Street, Gassaway, WV 26624. The entire store is being closed, and the closure is expected to be permanent.

The number of employees whose positions will be eliminated and whom will be separated from their employment (subject to bumping rights) upon the store’s closure between January 1, 2023 and January 31, 2023 is (including both full-time and part-time) Fifty-Seven (57). A list that includes the affected job titles or classifications and the number of employees within each affected job title or classification is enclosed. Fifty-Five (55) of the affected employees have certain bumping rights. The other two (2) affected employees do not have bumping rights.

Fifty-Five (55) of the affected employees are represented by a union, United Food and Commercial Workers Local 400. Its president is Mark Federici. The union’s mailing address is 8400 Corporate Drive, Suite 200, Landover, MD 20785. Its telephone number is 301-459-3400. The other two (2) affected employees are not represented by a union.
