Re: **Notice of Layoff and Business Closure (WARN ACT NOTICE)**

As a result of significant changes and financial impacts to our business operations in West Virginia, we have evaluated and determined that a business closure for all of our operations in the State will take place effective April 26, 2025. This letter provides you with official notice consistent with the Worker Adjustment and Retraining Notification Act ("WARN"), 29 U.S.C. Section 2101, et seq.

As a Behavioral Health Organization, primarily funded by Medicaid and State and Federal payors, we have received significant reductions in our contracts that have hindered our ability to meet the financial responsibilities of business management, resulting in the very difficult decision to bring our business relationships in West Virginia to a close as listed above.

We recognize the impact of this decision, our esteemed clients, valued employees and their families, and the broader communities we've served and look forward to the opportunity to serve West Virginians in the future.
