Re: Mass Layoff and Closure of JeniusBank

To whom it may concern:

Pursuant to the federal Worker Adjustment and Retraining Notification Act, 29 U.S.C. § 2101 *et seq.* (the “WARN Act”), SMBC MANUBANK (the “Company”) is issuing this notice to inform you that the Company will be undertaking a permanent mass layoff. The mass layoff is due to the decision of the Company to wind down and close JeniusBank, its digital banking unit.

We have sent this notice to every state where an affected individual resides pursuant to our understanding of the regulations applicable to the federal WARN Act (20 C.F.R. § 639.6), which provide that: “Notice also must be served on the State dislocated worker unit and the chief elected official of the unit of local government within which a closing or layoff is to occur.” The total number of affected employees in West Virginia is one. The employee works remotely. There is no physical JeniusBank office or location in West Virginia.

The affected employees are being informed today that their employment will be terminated at the end of the 60-day notice period, *i.e.*, on or around August 3, 2026. All affected employees will receive their regular wages and benefits during the 60-day notice period.

The mass layoff is being conducted throughout the entire United States and all affected employees’ separation from employment at the Company will be permanent.

The Company submits this notice to satisfy any obligation that may exist under the WARN Act. There will not be any bumping rights to other positions for the affected employees. Attached is a list of the job titles of positions that will be affected and the number of affected employees in each job position.
